**MINIMUM NUMBER FOR SOLE BOOKING: 60**

If this number cannot be guaranteed, Teen Ranch may arrange a combination booking with another group. If you wish to make a sole booking you must confirm that your minimum number will be 60, six months prior to your camp. In the event that you have made a sole booking and you have less than 60, you will be required to pay for 60. Teen Ranch reserves the right to cancel a camp if there is insufficient patronage. In this case, any deposits will be refunded.

**CAMP PROGRAM:**

**BOOKING PROCEDURE:**

Please call for available dates for a tentative booking (ie. without deposit) and this will be held for two weeks. To secure your booking, complete the application form below, detach and return with a \$400 deposit. The balance of camp fees is to be paid on receipt of invoice with one collective cheque.

**CANCELLATION:**

Deposit refunds will only be given for cancellations made 60 days in advance of the camp date. Groups cancelling with less than 60 days notice to the campsite will not have their deposit returned. In the event of a cancellation by the campsite the hirer shall be entitled to a full refund of all monies paid.

In signing this declaration I acknowledge on behalf of the group attending Teen Ranch for the camp that the paragraph above constitutes a risk warning under the terms of the *Civil Liability Act 2002 (New South Wales)*, and I hereby on behalf of the members of our group release Teen Ranch, its officers, employees and volunteers from liability to the extent permitted under the terms of that Act.

**Medical Assistance:** In the event of injury or illness of any student, I acknowledge that the group will be responsible at all times for obtaining necessary medical consents from the parents/guardians of campers, and for contacting parents/guardians, but in the event of emergency, on behalf of the group I authorise Teen Ranch to obtain all necessary medical assistance, including ambulance transport and hospital accommodation, and the group agrees to pay for all related fees and expenses.
